1. The Democratic Socialist Republic of Sri Lanka has received a loan from the Asian Development Bank (ADB) towards the cost of Local Government Enhancement Sector Project - Additional Financing (LGESP-AF) and intends to apply part of the loan funds to cover eligible payments under the above-mentioned Contract.
2. The Chief Secretary, Central Provincial Council, Palkelele, Kundasale Sri Lanka (Chairman, Provincial Procurement Committee) invites sealed bids from eligible bidders for the work mentioned above.
3. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure (NCB/1S1E) and is open to all bidders from eligible countries as described in the bidding document
4. Only eligible bidders with the following key qualifications should participate in this bidding:
  - (a) National Bidders shall have CIDA (Formerly ICTAD) registration Category C4 or above in water supply and sewerage and shall fulfil the qualification given in 4 (c) below
    - i. In case of JV between local bidders only, the Lead partner should have the required CIDA (Formerly ICTAD) registration.
  - (b) Foreign bidders shall fulfil the qualification criteria given in 4 (c) below.
    - i. In case of JV between local and foreign bidders, the local bidder should necessarily have the specified CIDA (Formerly ICTAD) registration even if the foreign bidder has the required qualification as mentioned in the Section 4(c).
