1. PURPOSE OF SUBMISSION

There are 15 manufacturers pre-qualified by the NWSBD to Supply DI Pipes & Fittings to the NWSDB as at 15th February 2022. As per the terms of the pre-qualification, the pre-qualified manufacturers have been requested to submit the required updated certificates and details before 05th August 2022 for periodical review in order to check whether they continue with the valid certificates to meet the pre-qualification condition.

The most of the manufacturers has not submitted the complete set of documents on time and several requests were made to fulfill the pre-qualification requirements.

2. NWSDB REQUIREMENTS

2.1 General

- (a) Article of Association of the Pipe manufacturing company certified by an Ambassador or High Commissioner or other diplomatic representative of Sri Lanka in the manufacturer's country.
- (b) Local Agency Agreement between the Manufacturer and the Local Accredited Agent attested by a notary Public/Attorney at Low and certified by an Ambassador or High Commissioner or other diplomatic representative of Sri Lanka in the manufacturer's country.

2.2 Technical

- (a) Product Conformity certificate for DI Pipes & DI Pipe fittings (EN545:2010/ISO2531:2009, EN598:2007) with annexes
- (b) Quality Management System certificate (with annexes) (ISO9001:2008/2015) for DI pipes & fittings manufacturing factories.
- (c) Product Conformity certificates (with annexes) for rubber rings (EN681-1/ISO4633)
- (d) Quality Management System certificate (ISO9001:2008/2015) (with annexes) for rubber ring manufacturing factory.
- (e) Type test certificate for restraint joints systems for DI Pipe lines (ISO10804-1)

2.2 Financial

Financial Capacity for last three years shall have working capital in excess of USD 250,000. Audited Financial statements shall be submitted.

3. PRESENT STATUS

Fifteen numbers of manufacturers were considered for periodical audit and details were requested from them through postal letters & E-mails. The manufacturer M/s. Jindal Saw Gulf LLC, M/s. Jincheng Chunchen Xinghui Industrial Co. Ltd., were not submitted their documents. Several request were made above two manufacturers, but they were not submitted.

Manufacturer, Suns Pipelines Co. Ltd. has informed that they have changed their local agent. Accordingly its evaluation has been conducted separately.

Therefore, following responded 12 manufacturers were considered for the Bi-annual Audit.

One manufacturer, M/s.Tata Metaliks Limited was not requested to submit the details for periodical audit as this manufacturer was evaluated and included to the pre-qualification list in February 2022.

4. VERIFICATION OF CERTIFICATES

The Product Conformity certificates for DI pipes, fittings & rubber rings, ISO 9001: 2015 Quality Management System certificate for DI pipes, fittings & rubber ring manufacturing factories, and type test certificates for Restraint joints were verified for the current validity of the same from the issuing authorities.

5. EVALUATION CRITERIA

Based on the submission of the above required certificates, manufacturers were evaluated by the current validity of the certificates. All these certificates were sent to the issuing Agencies for the verification of Authenticity of certificates for the successful manufacturers. The valid certificates holders are listed in **Table-1**, and they were considered for pre-qualification list.

Some manufacturers who have not submitted the required certificates have considered as disqualified according to the prequalification application. As well there are some certificates which were not verified. The manufacturers whom the certificates were not verified for the authenticity by the issuing authority are also not pre-qualified.
